B1. Performance Standards

In order to facilitate efficient and cost effective regulation by the Florida Engineers Management Corporation ("FEMC"), the following performance standards and measurable outcomes are adopted:

(1) FEMC shall make a determination of legal sufficiency within 30 days of receipt of a complaint.

In the First Quarter of Fiscal Year 2014/2015, <u>34</u> total new complaints were received of which <u>22</u> were complaints against licensees and <u>12</u> were complaints against unlicensed individuals or entities. Of the new complaints, <u>16</u> licensed complaints were deemed legally sufficient, <u>3</u> licensed complaints were deemed legally insufficient, and <u>3</u> licensed complaints are undetermined at the end of the First Quarter point, as they are still within the 30 days of determination and are still in the initial review process. Of the new complaints, <u>9</u> unlicensed complaints were deemed legally sufficient, <u>1</u> unlicensed complaint was deemed legally insufficient, and <u>2</u> unlicensed complaints are undetermined at the end of the First Quarter point, as they are still within the 30 days of determination and are still in the initial review process.

(2) Within fifteen days of receiving a complaint that is determined to be legally sufficient, FEMC shall furnish to the subject or the subject's attorney a copy of the complaint or document that resulted in the initiation of the investigation.

Of the <u>25</u> cases deemed legally sufficient, the subject (or subject's attorney) was notified and furnished a copy of the complaint, or, in the case of some unlicensed cases, furnished with a Cease and Desist Order resulting in 100% compliance with the Rule.

(3) FEMC shall provide status reports to the Board regarding all outstanding disciplinary cases at every other regularly scheduled meeting of the Board. The status report shall include all legally sufficient disciplinary cases until entry of a final order by the Board. Upon entry of a final order, FEMC shall notify the licensee's employer of the action taken by the Board.

Status reports were submitted to the Board at the August, 2014 FBPE meeting. As far as FEMC can reasonably ascertain the existence of an employer for Respondent, FEMC now has 100% compliance with that requirement.

(4) FEMC shall refer to the Board any investigation or disciplinary proceeding not before the Division of Administrative Hearings pursuant to Chapter 120, Florida Statutes, or otherwise completed by FEMC within one year after the filing of a complaint.

Referenced in the previous quarterly report, at the end of the Fourth Quarter of the fiscal year 2013 –2014, <u>20</u> cases were identified as being more than one year old; however, that number should have been <u>21</u>, as 2 cases that were combined into one case were counted as only 1 case in the Fourth Quarter of Fiscal Year 2013/2014; and, of those <u>21</u> cases, <u>4</u> have been resolved. As a result of aging, there are <u>10</u> additional cases that reached year old status during the Fourth Quarter of Fiscal Year 2013/2014 thus making a total of <u>27</u> cases which are more than one year old at the end of the First Quarter for the 2014/2015 Fiscal Year.

(5) FEMC shall notify the person who filed the complaint of the status of the investigation every six months, including whether probable cause has been found, when the case is on the agenda for consideration by the Board, and the status of any administrative proceeding or appeal.

FEMC is in 100% compliance with this section.

(6) At least 90 days before the end of a licensure cycle, FEMC shall forward a licensure renewal notification to active or inactive licensees at the licensee's last known address of record with FEMC.

FEMC is in 100% compliance with this section.

(7) At least 90 days before the end of a licensure cycle, FEMC shall forward a notice of pending cancellation of licensure to a delinquent status licensee at the licensee's last known address of record with FEMC.

FEMC is in 100% compliance with this section.

(8) Upon receipt of an application for a license, FEMC shall examine the application and, within 30 days after such receipt, notify the applicant of any apparent errors or omissions and request any additional information FEMC is permitted by law to require.

(10) If an applicant seeks a license for an activity that is exempt from licensure, FEMC shall notify the applicant and return any tendered application fee within 30 days after receipt of the original application.

FEMC is in 100% compliance with this section due to the fact that it has not received any application for an exempt activity.

(11) FEMC shall maintain the Board's web page and update the web page within 14 days of the date the updates go into effect. Administrative complaints shall be posed no later than 30 days after the recommendation by the probable cause panel. All active disciplinary cases shall be posted on the web page, including the final action taken by the Board until the terms of the final order are completed or until the licensee becomes inactive, retires, relinquishes the license or permits the license to become null and void.

FEMC is in 100% compliance with this section.

## Corrective Action Plan for violation of confidential data and information:

- 1. FEMC shall ensure that all links and documents containing confidential and/or exempt data or information have been completely removed from their website and web server(s). All documents were removed from the FBPE website on or about August 14, 2014, shortly after discovery of the breach. Furthermore, all links to website documents were turned off after it was discovered that a search of the site would produce documents with the confidential or exempt information.
- 2. FEMC will need to work with groups such as Archive.org, Coral Cache, and Google Cache to ensure that cached pages containing confidential and/or exempt data or information are removed from the Internet. Although the information is not easily searchable, it does exist on the Internet. Archive.org has already been utilized with the website. Users receive the message "Page cannot be crawled or displayed due to robots.txt."
- 3. All information that has been posted to the Internet shall be reviewed to ensure that all confidential and/or exempt data or information has been removed or redacted. Please refer to Florida Statutes for additional information on handling confidential or exempt information. A complete review was conducted on or about August 14, 2014 pursuant to the requirements of Florida Statutes. All confidential or exempt data or information found to be on the FBPE website was redacted or removed. FEMC has decided as of October 10, 2014 to only publish agenda and minutes from meetings and all other materials will be considered a public records request.
- 4. After all information has been reviewed for removal or redaction, FEMC shall provide a final list to the department of each individual affected by the release of their confidential and/or exempt information. A list of each individual who might have been affected by the release of their confidential or exempt information was provided to Yvette Pressley, FEMC Contract Monitor, on August 15, 2014...
- 5. FEMC shall notify each individual affected by the release of their confidential and/or exempt information, and must provide proof of same to the department. The notice to an affected individual shall be by one of the following methods:
  - a. Written notice sent to the mailing address of the individual in the FEMC records; or

- b. E-mail notice sent to the e-mail address of the individual in the records.
- **c.** The notice to an individual with respect to release of confidential and/or exempt information shall include, at a minimum:
  - i. The date, estimate date, or estimated date range of the release of confidential and/or exempt information.
  - ii. A description of the confidential or exempt information that was accessed or reasonably believed to have been accessed as a part of the release of confidential and/or exempt information.
  - iii. Information that the individual can use to contact FEMC to inquire about the release of confidential and/or exempt information that FEMC maintained about the individual.

Written notices will be mailed by USPS mail on or before September 12, 2014, pursuant to direction from Yvette Pressley, FEMC Contract Monitor. The notice, a draft of which is attached, will notify each individual of the date, estimated date, or estimated date range of the release of confidential or exempt, information, the type of information that was released, and how to contact FEMC to obtain further information. As of October 10, 2014 FEMC has only been contacted by three individuals who received the letter

- 6. FEMC shall establish procedures for maintaining confidential and/or exempt information, including procedures for the release of otherwise public information or documents in any manner. A copy of the procedures shall be provided to the department for review. FEMC is in receipt of DBPR's Public Records Manual dated April 7, 2014, as well the 2014 Sunshine Law Manual, both of which will be used until such time as FEMC develops its own procedural manual.
- 7. FEMC shall develop a secure mechanism for communicating confidential and/or exempt information to members of the FBPE. FEMC currently utilizes a secure file transfer protocol (FTP) called FBPE Basecamp to transfer files securely to Board members and investigators and will continue utilize the FTP for communicating confidential and/or exempt information. FEMC also uses a program called BoardEffect on the Board member iPads. This program allows for the secure upload of all meeting materials to be viewed only by Board members and staff.
