B. Ratification of the actions taken during the FBPE Application Review held January 10, 2017

Ms. Sammons stated that two corrections needed to be made the FE Exam Applicants list:

- Muhammah Naseer lacks 4.8 hours of math & basic science and 2 of 3 required sciences.
- Olfat Sarhang Zadeh lacks either a chemistry or biology.

Upon motion by Mr. Hahn, seconded by Mr. Dove, to approve the ratification list as amended, the motion passed.

C. Public Hearing on Rule 61G15-24.001

Mr. Fiorillo stated this a reduction in fees because we cannot charge for more a delinquent fee than for a renewal fee. Mr. Harris stated that this item should have been handled at the December meeting with the other fee changes but it was missed.

Upon motion by Mr. Hahn, seconded by Ms. Boza, to approve the proposed Rule amendment to 61G15-24.001 as presented, the motion passed.

Mr. Harris asked if the proposed rule amendment will have an adverse impact on small business or will proposed rule amendments would be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within one (1) year after the implementation of the rule.

Upon motion by Mr. Hahn, seconded by Mr. Bracken, that the proposed rule amendment will have no adverse impact on small business and will not increase regulatory costs, the motion passed.
