

Mr. Harris explained the basis for the denial. Ms. Burzo holds a BS & MS in Architectural Engineering from Pennsylvania State University, University Park Campus. The denial was based on experience as the experience appears to be non-qualified experience, "construction management."

Upon motion by Mr. Fleming, seconded by Mr. Shah, to reconsider the notice of intent to deny, vacate the notice and approve the application, the motion passed.

- Mr. Drury recused himself from the case.

Mr. Harris explained the basis for the denial. Mr. Martins holds a BS in Electrical Engineering from Polytechnic Institute of Castelo Branco. The denial was based on education. Mr. Martins lacks both a chemistry or biology course and 4.5 hours of general education.

Upon motion by Mr. Fleming, seconded by Mr. Albergo, that Mr. Martins was properly served with the Notice of Intent to Deny and filed an Election of Rights or other responsive pleadings within the time period required by law, and requesting a section 120.57(2), F.S.

hearing not involving disputed issues of material fact, and to convene such hearing; to accept the complete application file, including any supplemental materials provided by Mr. Martins, into the record; to adopt the factual allegations contained within the Notice of Intent to Deny as the board's findings of facts; to adopt the legal conclusions contained in the Notice of Intent to Deny as the Board's conclusions of law, and find the facts adequately support the denial of the application for Florida licensure; to deny the application for Florida Licensure, and to stay this decision for 15 days, to direct staff to contact the applicant and to offer the option to withdraw the application in writing, the motion passed. If Mr. Martins withdraws within the time period, the staff is delegated authority to accept the withdrawal and close the file. If Mr. Martins does not withdraw, in writing, within the stated time period, a Final Order of Denial shall be entered.

- T. Informal Hearing on Application for Licensure by Endorsement

 - Mr. Ayakannu was present and sworn in prior to addressing the board.

Mr. Harris explained the basis for the denial. Mr. Ayakannu holds a BS in Civil Engineering from National Institute of Technology and an MS in Civil Engineering from South Dakota School of Mines and Technology. The denial was based on education. Mr. Ayakannu lacks 3 hours of general education. On February 10, 2020, Mr. Ayakannu submitted a course certificate from Coursera for a course in "Introduction to Psychology."

Mr. Ayakannu addressed the board and provided the board with a transcript from Phillips University that shows a Principles of Management course that has not been included in his evaluation. Discussion followed.

Upon motion by Mr. Shah, seconded by Mr. Fleming, to reconsider the Notice of Intent to Deny, Vacate the Notice of Intent to Deny, and certify the applicant for licensure based on the evidence provided by the applicant, the motion passed.

- U. Board Appearance on Application for Principles and Practice Examination

Mr. Harris explained the basis for board appearance. Mr. Norman holds a BS in Civil Engineering from Florida State University. The denial was based on his past criminal history.

Mr. Norman addressed the board. Discussion followed.

Upon motion by Mr. Drury, seconded by Mr. Shah, to reconsider the Notice of Intent to Deny, Vacate the Notice of Intent to Deny, and approve the application of Mr. Norman, the motion passed.

#2. Kevin Glass

Mr. Glass was present and sworn in prior to addressing the board.

Mr. Harris explained the basis for the board appearance. Mr. Glass holds a BS in Civil Engineering from Florida State University and MS in Civil Engineering from Carnegie Mellon University. The denial was based on experience.

Mr. Glass addressed the board, providing sworn testimony regarding his experience.

Discussion followed.

Upon motion by Mr. Drury, seconded by Mr. Shah, to reconsider the Notice of Intent to Deny, Vacate the Notice of Intent to Deny, and approve the application of Mr. Glass, the motion passed.

#3. Joseph Joson

Mr. Harris stated that staff received a request from Mr. Joson to withdraw his application.

Upon motion by Mr. Fleming, seconded by Mr. Shah, to vacate the Notice of Intent to Deny and allow Mr. Joson to withdraw his application, the motion passed.

V. Hearing on Request to Extend deadline to submit documentation required by Final Order

#1. Hardik Shah

Mr. Harris explained the request by Mr. Shah. Mr. Shah appeared at the October 2019 FBPE Board meeting to discuss to application, a final order was issued that allowed Mr. Shah 90 days from the issuance of the order to complete 3 hours of general education. The final order was issued on November 1, 2019 and the 90-day time limit expired on January 30, 2020. Mr. Shah emailed the Executive Director on December 10 and December 17 asking for an extension. As of February 5, 2020, staff has not received any CLEP transcripts for Mr. Shah.

Upon motion by Mr. Drury, seconded by Mr. Fleming, to deny the request for an extension, the motion passed.

Mr. Harris stated that the informal hearing needed to be continued from the October 2019 meeting.

Upon motion by Mr. Fleming, seconded by Mr. Drury, to adopt the factual allegations contained within the Notice of Intent to Deny as the board's findings of facts; to adopt the legal conclusions contained in the Notice of Intent to Deny as the Board's conclusions of law and find the facts adequately support the denial of the application for Florida licensure; and to deny the application for Florida Licensure for Mr. Shah, the motion passed.

W. Review Supplemental Materials and take final action on Application for Licensure by Endorsement

#1. Terry Olson

Mr. Harris explained the basis for the review of the supplemental materials. Mr. Olson holds a BS in Mechanical Engineering from North Dakota State University. The denial is based on experience. Mr. Olson lacked 48 months verified engineering experience. Mr. Olson has submitted updated work experience verifications with NCEES and FBPE. Mr. Olson returned his election of rights requesting a formal hearing but after discussion with Mr. Harris, Mr. Olson has elected to have his case heard before the board and not have a formal hearing.

Discussion followed.

Upon motion by Mr. Fleming, seconded by Mr. Albergo, to reconsider the Notice of Intent to Deny, Vacate the Notice of Intent to Deny, and approve the application of Mr. Olson, the motion passed.

X. Determination of Dispute of Material Fact/Referral to DOAH for Hearing

#1. David Thomas

Mr. Harris explained the basis for the denial. Mr. Thomas holds a BS in BS in Electrical Engineering Technology from Southern Polytechnic State University (now Kennesaw State University). The basis for denial is experience and exams. Mr. Thomas has not passed the NCEES FE Exam and does not have the required 6 years of verified engineering experience with an ETAC degree. Mr. Thomas returned his election of rights requesting a formal hearing but after discussion with Mr. Harris, Mr. Thomas has elected to apply using the active-duty military waiver and submit the required application including fingerprints and not have a formal hearing. As of February 10, 2020, Mr. Thomas has NOT submitted the application or fingerprints as required for this waiver.

Discussion followed.

Motion by Mr. Drury, seconded by Mr. Fleming, to reconsider the Notice of Intent to Deny, Vacate the Notice of Intent to Deny, and to allow staff to approve the application of Mr. Thomas if the required supplemental materials are provided, the motion passed.

Upon motion by Mr. Shah, seconded by Mr. Albergo, that the respondent was properly served with the administrative complaint and failed to file an election of rights or other response as required by law within the required time, and that by failing to respond in writing as required by law the respondent has waived the right to request a hearing, and to grant the motion that the respondent has forfeited the right to select an administrative hearing under section 120.569 and 120.57(1), and to convene a hearing under section 120.57(2), F.S., to accept the complete investigative file, including any materials provided by the Respondent or Respondent's counsel, into the record, hat the Board adopt the findings of facts contained within the administrative complaint as the Board's findings of facts and to adopt the conclusions of law contained in the administrative complaint as the Board's conclusions of law, the motion passed.

The Probable Cause Panel recommendation was an administrative complaint, administrative costs of \$1,126.20, administrative fine of \$4,000(\$2,000.00 per count), reprimand, appearance before the Board to discuss how this situation occurred, what improvements and quality control measures will be implemented to prevent this circumstance from occurring in the future, restricted from practicing structural engineering until he takes and passes the NCEES 16-hour Structural Exam with project reviews at 6 and 18 months after he takes and passes NCEES 16-hour Structural Exam, one (1) year suspension, successful completion of the board-approved intermediate engineering professionalism and ethics course, and successful completion of the board's study guide.
