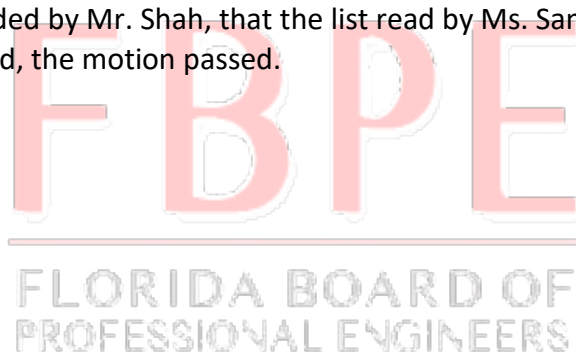
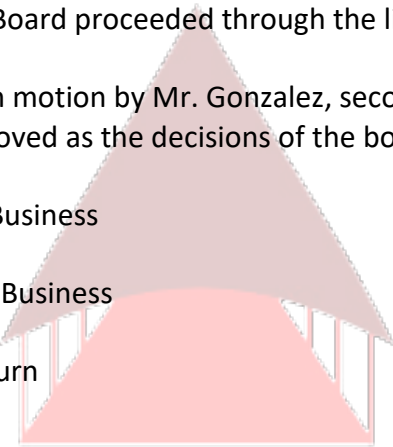
Ms. Sammons read the list of the applicants and the reasons for review for each application. The Board proceeded through the list with discussion as appropriate to the decision.
