Stat.</p> An inactive status licensee may change to active status at any time, provided the licensee meets all requirements for active status, pays any additional licensure fees necessary to equal those imposed on an active status licensee, pays any applicable reactivation fees as set by the board, or the department when there is no board, and meets all continuing education requirements as specified in this section. The board, or the department if there is no board, may not require an inactive or delinquent licensee, except for a licensee under chapter 473 or chapter 475, to complete more than one renewal cycle of continuing education to reactivate a license. I have read these terms and conditions for Active Status and all information has been attached to this application. Upon return to Active status, I understand that I will be required to complete required continuing education requirements as found in Rule 61G15-22.001 for the upcoming renewal cycle.
