The interpretation that the rule 61G15-35.003 (c) does not state the Inspection requirement, is not a sufficient reason to credit component inspections, since it is succinctly described on top of the inspection form of the SI application. Due to its importance, it is repeated on each and every page of the experience form. Per rule 61G15-35.003 (2) the instruction and application form are incorporated into the rules; 2. (a) Thanks for pointing out the typo, which will be corrected.</p> <p>(b) Applicant's interpretation on this rule is incorrect. If a building meets the criteria of a threshold building, which a different state does not call as a threshold building, we will accept the experience as "equivalent" as long as it meets the Florida definition. E.g. A person who inspected a 40 story building in NY has performed the inspection 'equivalent' to the threshold building since only Florida defines such buildings as 'threshold building'.</p> <p>(c) Cities do allow Threshold inspections on non-threshold buildings (almost always at the request of the owners since this is an added cost to the owner). It could be due to the fast track nature of the project, or the owners who emphasize on quality. The definition of threshold building is defined and therefore only experience garnered on such building can be credited.</p> <p>3. The applicant had worked under six SI's. None of them are verifiers. More than one had mentioned about his experience as a testing engineer. One specifically mentioned he has no knowledge of 'his threshold inspection' experience. If experience is met, I want to see him complete the new form or get verified by the SI's.</p>
