The 6-month project review was brought before the May 10, 2023, Panel due to deficiencies. The Panel decided to see how the Subjects 18-month review would go before making a recommendation on how to proceed. The PCP recommendation was that Mr. Bishop be offered a chance extend his probation to allow for another six-month project review. The Subject has agreed with the PCP, and an amended settlement stipulation was received on March 18, 2024. This case is being presented to the Board, acceptance/approval of the amended settlement stipulation.

Upon motion by Ms. Myers, seconded by Mr. Shah, to accept the amended settlement stipulation, the motion passed unanimously.
